IV. Sunshine Law - Mr. Christmann read the following statement -

The New Jersey Open Public Meetings Law was enacted to ensure the right of the public to have advance notice of and to attend the meetings of public bodies at which any business affecting their interests is discussed or acted upon. In accordance with the provisions of this act, Mendham Township Board of Education has caused notice of this meeting to be published by having the date, time, and place thereof posted in the Mendham Township Board of Education Office, sent to the Clerk of Mendham Township, and the Observer Tribune and the Daily Record. This is an official meeting.

The sick leave bill, A-5060/S-3440, was signed into law on July 3, 2023. This law expands the permissible use of sick days for public school staff. The previous law limited the use of the 10 annual statutory sick days to a teacher's own illness, injury, disability, or quarantine due to exposure to a contagious disease. The new law maintains those purposes but also allows sick days to be used for the following:

- 1. Recovering from, diagnosing, or treating a health condition (mental or physical) or for preventative medical care.
- 2. Caring for a sick family member, providing diagnosis, treatment, or care for their health condition (mental or physical), or offering preventative medical care.
- 3. Assisting oneself or a family member who is a victim of domestic or sexual violence, including the need for medical attention, services, counseling, relocation, or legal proceedings.
- 4. Taking bereavement leave for a family member (up to seven days).
- 5. Attending a child's school-related conference, meeting, function, or other event at the request of a school staff member, or attending a meeting related to the child's health condition or disability.
- 6. Using sick leave if a child's school or daycare is closed by a public official's order or due to a state of emergency or public health emergency.

The definition of family members is broad and includes children, grandchildren, siblings, spouses, domestic partners, civil union partners, parents, grandparents, and other close relations that have an equivalent family relationship (blood relation not required). The term "children" encompasses biological, adopted, or foster children, stepchildren, legal wards, or the child of a domestic partner or civil union partner.

This law does not diminish any collectively bargained rights. For example, if family illness days and/or bereavement leave are included in the teacher's contract (which we have here in Mendham), those days remain in addition to the 10 statutory sick days per year.

Regarding notification, if sick leave is foreseeable, a minimum of seven calendar days' advance notice is required. If the need for sick leave is not foreseeable, notice should be given as soon as

possible, provided that the employer has informed employees of this requirement. Employers can prohibit foreseeable sick leave on specific dates, and if unforeseen sick leave occurs on those dates, reasonable documentation may be required.

If sick leave is used for three or more consecutive days, the employer may request reasonable documentation to verify that the leave is being used for a valid purpose. For those caring for a sick family member, a signed document from the healthcare provider is sufficient. In the case of a child's school or daycare closure, a copy of the order from a public official or health authority serves as valid documentation. Victims of domestic or sexual violence may need to provide reasonable documentation depending on the reason for leave, which can come from sources such as the court, agency, social worker, law enforcement, counselor, attorney, or other relevant professionals assisting the individual.

IDEA-B State Fiscal Year 2024 Entitlement Allocations and Electronic Grant Application InformationThe Individual with Disabilities Education Act (IDEA) Part-B State Fiscal Year (SFY) 2024 allocations were made available on the New Jersey Department of Education (NJDOE) IDEA Allocations webpage. Section 611 (Basic 3-21) - \$ 183,271 and Section 619 (Preschool 3-5) awards are distributed on a formula basis to local educational agencies (LEAs) and state agencies. - \$9,915

SFY 2024 IDEA-B Electronic Grant Submission The SFY 2024 IDEA grant application is due by Monday, July 31, 2023.

Grant Project Period Timelines/Obligation of Funds

LEAs and state agencies that submit their applications in substantially approvable form by the due date may obligate these funds beginning July 1 of the fiscal year for which the funds were appropriated. The grant project period for SFY 2024 runs from July 1, 2023, through September 30, 2024, with an additional 12-month period of availability of unexpended funds to be budgeted in the following fiscal year.

Revised 2023-2024 Maximum Expenditure for Nonpublic School Transportation

Pursuant to the 2023-2024 Appropriations Act, the maximum allowable per-student expenditure for nonpublic school transportation for the 2023-2024 school year is \$1,165, or a daily rate of \$6.47 (\$1,165 divided by 180). The daily rate applies when the student's application is received after the start of school or when the student withdraws from the nonpublic school before the close of the school year.

If transportation cannot be provided, parents are entitled to \$1,165 as aid-in-lieu of transportation. Each resident district board of education that provides transportation to remote public school students is required to provide transportation services to eligible nonpublic school students. In accordance with N.J.A.C. 6A:27-2.3(b), the parents of each nonpublic school student

and the nonpublic school administrator shall be notified by the district board of education as to the determination of each application for nonpublic school transportation by August 1 of each year.
